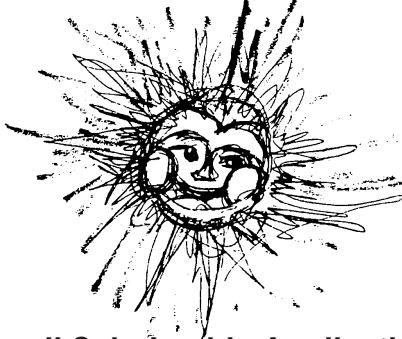

Calaveras County Arts Council Scholarship Application Procedure:

1. Read through application blank before filling it in.
2. Leave nothing blank. If a question does not apply, write "N/A" in the space.
3. Complete the application page.
4. Be precise: details are important.
5. Include with your application the following:

A. Write a ONE-PAGE-ONLY essay about yourself, and how you are involved with the arts. Include your interests and your goals regarding education, career, profession, trade. State why you need the grant and when you will need it. You need not limit yourself to educational interests. Write about things theatre important to you. Also include information about your past experiences in the arts such as: public performances, published works, places where your work has been shown and discuss any other activities involving the arts that you have participated in.

B. Please include TWO LETTERS of recommendation from persons associated with the arts.

C. Date your application and sign it.

Grants from CCAC must be claimed within six months of the date of the award, unless we're notified.

Grant amounts for the year 2011:

\$750 **Arts of Bear Valley Memorial Scholarship** (1 winner only from all high schools or the public at large)

\$500 **Robert Atkinson Scholarship** (one each for Bret Harte and Calaveras High Schools and Mtn Oaks)

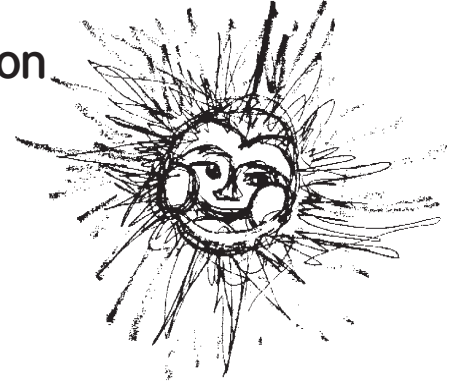
